Nicole is committed to working toward systems change that will create equal access, improved supports, and full lives for all individuals with disabilities. Nicole has served in various roles, including her appointment as a Senior Policy Advisor and Manager of the Employment First Initiative in Illinois, where she collaborated to draft a statewide strategic plan to make Employment First the reality

in Illinois. Prior to that, Nicole served as the CEO/President of the Institute on Public Policy for People with Disabilities.

Nicole is an accomplished special education attorney and an advocate for students with disabilities,. She has written several articles and developed trainings, and has served as a public policy consultant with Autism Speaks.

Nicole's brother, Christopher, experiences autism and has always motivated Nicole in her work. Nicole discovered her passion for influencing public policy by working with legislators in Springfield, IL to educate them on issues that impact the lives of individuals with disabilities and encourage them to support permanent solutions. Nicole has been trained in the field working with people with I/DD; she trained in the law, focusing her studies on education and disability related issues; and, trained on advocacy issues that affect the I/DD community.

Nicole received her JD and Child and Family Law Certificate, from Loyola University Chicago. She received her in Recreation, Sport and Tourism with Honors from the University of Illinois.

Luncheon Keynote Speaker

Lilia Teninty

Director, Oregon Office of Developmental Disabilities Services (ODDS)

In her role as the Director of the Office of Developmental Disability Services (ODDS) in DHS, Lilia is responsible for the development, oversight and delivery of intellectual and developmental disability services across Oregon.

Lilia brings with her over 13 years of experience, 11 of those working specifically with Intellectual/Developmental Disability (I/DD) programs. She has worked in several states, in a variety of roles. She began her career in the field of I/DD working for a small non-profit that provided assistive technology to people with disabilities. In 2003 she began working for the State of Indiana, where she supervised the Medicaid waiver unit and moved on to become the Chief of Staff for the Division of Disability and Rehabilitative Services (2006-2007). Lilia later accepted the position of Director of the Division of Developmental Disabilities for the State of Illinois (2007-2011). In 2011 she moved to Oregon to work for the Human Services Research Institute (HSRI). As a Senior Policy Specialist at HSRI, she provided consultation on Medicaid policies and funding mechanisms for people with I/DD to several states.

Prior to starting her career, Lilia earned her Bachelor of Arts in International Relations from Mills College and her Masters of Public Affairs from Indiana University. Lilia has a passion for public service and has dedicated most of her career to serving those with intellectual and developmental disabilities.

Managing Partner, Autism Risk Management

Dennis Debbaudt is the proud father of Brad, a young man who has autism. In the 1980s, he wrote for the Detroit News and worked with network television current affairs programs in the United States, Canada, and United Kingdom. A professional investigator and journalist since 1977, Dennis turned his attention to autism spectrum conditions in 1987 after his son was diagnosed with autism. His first

report, Avoiding Unfortunate Situations, was published in 1994. He's since authored more than 30 articles, books, and chapters including Autism, Advocates and Law Enforcement Professionals.

As managing partner of Debbaudt Legacy Productions, LLC, Dennis produced and wrote the scripts for the training videos Autism & Law Enforcement Roll Call Briefing (2004), Autism, Fire-Rescue and Emergency Medical Services Video (2009), and Autism in the Criminal Justice System (2009).

Over the past 19 years, Debbaudt has provided training and developed training materials for law enforcement, first response, and criminal justice professionals throughout the United States, Canada, Australia, Iceland, New Zealand, and United Kingdom.

Creating a Personal Safety Plan for Any Age

Does everyone need a plan to manage personal safety? Individuals with I/DD and their supporters should create a personal safety plan that meets unique needs and comes in handy when interacting with police or other first responders. Disclosure of important information can quickly lower the temperature of the contact for all involved. Discussing what, when, how and who to disclose to, and practicing your safety and disclosure plan with people you trust, can help prepare you for the unexpected. Peter Berns

Peter V. Berns is a nationally recognized nonprofit sector leader and public interest lawyer. He has been the Chief Executive Officer of The Arc, the world's largest community-based organization of and for people with intellectual and developmental disabilities, since July 2008. Under his leadership, the organization has charted an ambitious course of progress, innovation and change with the development of a Strategic Framework for the Future of The Arc.

Before joining The Arc, Peter worked for 16 years as the Executive Director of the Maryland Association of Nonprofit Organizations. In that capacity, he built the Association from a start-up to a position of prominence in the nonprofit community, with nearly 2,000 members of all sizes, all sectors and from all regions of the state. In addition, he served as Chief Executive Officer of the Standards for Excellence Institute since its inception in 2004.

Peter came to The Arc with a track record of success in the areas of nonprofit management, governmental relations and advocacy. As a public policy advocate, he was critical to reforming state and federal Medicaid regulations improving life for persons with disabilities and their families. He was named to the Nonprofit Times Power and Influence Top 50 list in 2000, 2002, 2003, 2004, 2005, and 2015.

In May 2011, President Barack Obama appointed Peter to the President's Committee for People with Intellectual Disabilities, which provided advice and assistance to President Obama and the Secretary of Health and Human Services on a broad range of topics that impact people with intellectual and developmental disabilities and their families.

Peter received his JD, cum laude, from Harvard Law School and he has an LLM in advocacy from Georgetown University Law Center. He received his BA in psychology, magna cum laude, from the University of Pennsylvania. He and his wife, Melissa Zieve, reside in Baltimore, MD with their four children.


